- LDR requirement of minimum 10-acre lots for parcels of 41 acres or greater get rid of it so they can make smaller parcels and keep the same density.
- Put some commercial strip on 41 south to Powell and on SR-50 (not specific as to where)
- Give people some type of notice so they see us before they do a parcel split so that they avoid creating an illegal parcel. Put up a sign in the Clerk's office.
- When they do a subdivision parcel split and it's labeled "no improvements" do not send it to Engineering (per Brian) and they won't need to charge \$2,000 since they don't review it. Or alternatively, if they review it and nothing is needed, charge less (\$500).
