	 Hernando County Construction Code 111.3 provides for issuance of Temporary Certificate of Occupancy (TCO) to use a portion or portions of a structure prior to the completion of the entire structure if the Building Official finds that portions of the building may safely be occupied prior to completion of the building final. Prior to the issuance of a TCO, a \$348.05 issuance fee must be paid. Hernando County Development Services may suspend or revoke the TCO if it is determined that the building is in violation of any Hernando County Code or Regulation. Prior to the expiration of the TCO, it is the responsibility of the Contractor to request required inspections for completion of permitted work. Approved final inspections are required by all applicable trades and departments prior to the issuance of a Certificate of Occupancy. If uncompleted work cannot be finished during the duration of the TCO, reapplication and a fee of \$348.05 is required. The TCO shall not be valid until acceptable inspections are completed, applicable fees are paid, the Certificate is signed by the Building Official or designee, and the Certificate has been posted in the occupied area. Temporary approvals are valid for a maximum of thirty (30) calendar days otherwise noted approval by the Building Official.
