	2017 6 th Edition Florida Building Code, Section R450.17 (Exception): The pool will be equipped with an approved safety pool cover that complies with ASTM F1346-91.
	2017 6 th Edition Florida Building Code, Section R450.17.1.9(1): All doors and windows providing direct access from the home to the pool will be equipped with an exit alarm complying with UL 2017 that has a minimum sound pressure rating of 85 decibels at 10 feet
	2017 6 th Edition Florida Building Code, Section R450.17.1.9(2): All doors providing direct access from the home to the pool will be equipped with self-closing, self- latching devices with positive mechanical latching/locking installed a minimum of 54" above the threshold, which is approved by the authority having jurisdiction All doors and windows leading to the pool must be shown on the plans.
6	2017 6 th Edition Florida Building Code, Section R450.17.1.9(3): A swimming pool alarm that, when placed in a pool, sounds an alarm upon detection of an accidental or unauthorized entrance into the water. Such pool alarm must meet and be independently certified to ASTM Standard F2208, titled "Standard Safety Specification for Residential Pool Alarms," which includes surface motion, pressure, sonar, laser, and infrared alarms. For purposes of this paragraph, the term "swimming pool alarm" does not include any swimming protection alarm device designed for individual use, such as an alarm attached to a child that sounds when the child exceeds a certain distance or becomes submerged in water.
国	2017 6 th Edition Florida Building Code, Section R450.17.1.10: Where an above ground pool structure is used as a barrier or where the barrier is mounted on top of the pool structure, and the means of access is a ladder or steps, the ladder or steps either shall be capable of being secured, locked or removed to prevent access, or the ladder or steps shall be surrounded by a barrier which meets the requirements of Section

I understand that not having one or more of the above installed at the time of final inspection, or when the pool is completed for contract purposes, will constitute a violation of Chapter 515, F. S., and will be considered as committing a misdemeanor of the second degree, punishable by fines up to \$500 and/or up to 60 days in jail as established in Chapter 775, F.S. I also understand that failure to comply is also a violation of the Florida Building Code and Hernando County Ordinance and may be punishable by fines ranging from \$500-\$5,000 and disciplinary action.
