A contract was completed on 10-03-2017 for installation of 10x10 concrete pad- 12 inches depth with 5000 PSI commercial grade concrete with commercial fiber mesh reinforcement and completed today 10-31-2017.

No local electricians have been available or will commit to having the man power needed to connect this generator to air supply source except Guadette Electric in Homosassa Springs, Florida as per exhibit A.


