1. Update from 5/14/2020 MPO Meeting

Mr. Diez advised the Media Release and Issues List from the 5/14/20 MPO meeting are included for informational purposes.

2. Status of Request for Qualifications – New Consultant Contracts

Mr. Diez advised the MPO has two consultant contracts and RFQ's were sent out earlier this year and the selection committee meeting is Friday May 29, 2020 to review the packets and make a recommendation.

3. Citrus Transit Development Plan – Major Update

Mr. Diez advised the consultant has completed the update on the Citrus County Development Plan and is going before the Citrus County BOCC for review and approval at their June 23, 2020 meeting.

1. Complete Streets Policy and Implementation Process

While there is no defined definition on what a complete street is, the effort is to integrate land use, users and people into transportation planning and discussion making. Complete streets are designed to be safe and accommodate all ages.

2. Transportation Improvement Program FY 2020-2024 (TIP/STIP) Amendment

Mr. Diez advised FDOT requested to amend the FY 2020-2024 TIP /STIP to include and updated phase for the Withlacoochee State Trail project. It was originally a design project but has been changed to design-build.

3. FY 2021-2025 Transportation Improvement Programs

Motion: Mr. McLean made a motion to approve the Transportation Improvement Program. Mr. Henize seconded, and the motion carried unanimously.

4. FY 2021-2022 List of Priority Projects (LOPPS)

Mr. Diez advised there was one change in the Transportation Alternatives (TA) List of Priority Projects (#38), the limits of the Suncoast Parkway Extension to 486 were corrected "from SR 44 to CR 486".

Motion: Mr. Reiland made a motion to approve the FY 2021-2022 List of Priority Projects with the correction to #38. Mr. McLean seconded, and the motion carried unanimously.
