PUBLIC OPEN HOUSE SUMMARY

MEETING HELD MARCH 29, 2022

A public open house was held for the Kass Circle – Spring Hill Drive Safety Improvements Project on Tuesday, March 29, 2022 from 6:00 p.m. to 8:00 p.m. at the People Helping People Facility, 1396 Kass Circle, in Spring Hill, FL. This public open house was conducted during the design phase of the project.

Public Notification

To provide advanced notification and encourage greater public participation, several ways were employed to let the community know about the public open house. Meeting invitation flyers were sent by email to elected officials, appointed officials and interested parties. The invitation flyers were mailed first class to property owners / tenants. Meeting information was posted on the Hernando County webpage and the project webpage. Invitation flyers were also hand delivered to businesses and properties within the project limits. The invitations included the date, time and location of the public open house, as well as a brief description of the project. Copies of the meeting invitation flyer, elected and appointed officials' and interested parties' email, and the property owner mailing list are included in Appendix A.



Media Notification

A press release was distributed by Hernando County to major local media outlets on March 22, 2022. A copy of the press release is included in Appendix B.

Public Open House Agenda

The public open house began at 6:00 p.m. Parking was available to accommodate all the attendees, including the differently abled. Signs were placed along Kass Circle and Spring Hill Drive to direct attendees to the meeting location and from the parking lot to the meeting room.



The meeting was an open house forum and attendees were invited to attend any time between 6:00 p.m. and 8:00 p.m. Members of the project team were available to discuss the project and answer questions.

Twenty-five people signed the sign-in sheet. A copy of the sign-in sheets is included in Appendix D.


Comment Form



PROJECT DETAILS

Hernando County will be implementing roadway and safety improvements for traffic channelization, pedestrian crossings, and planning for a bus pull out bay and shelter improvements in the Kass Circle Community. Spring Hill Drive, between Pinehurst Drive and Deltona Boulevard, is one of the most heavily traversed roads in Hernando County.

Traffic channelization improvements will include eliminating dangerous left turn movements entering and exiting Spring Hill Drive and developing plans for a channelized intersection into the main entranceway into the Spring Hill Plaza. Median modifications are anticipated at Kass Circle (west), Acorn Circle and Port Court.

The pedestrian safety improvements include the engineering and design of flashing beacon pedestrian crossings at Kass Circle (east) and the main entranceway to Spring Hill Plaza. The crosswalks will connect to existing sidewalks and will increase pedestrian safety by formalizing the interaction between automobiles and pedestrian traffic, and increase access to neighborhood amenities for residents, including the main grocery store and pharmacy.

Improvements also include the design of bus pull out areas and a bus shelter for Kass Circle residents.

Additional roadway improvements include extending the left turn lanes for westbound at Pinehurst Drive, the eastbound and westbound left turns at Acorn Circle, and the eastbound left at Kass Circle (east).







Slide 3 Meeting Agenda

The purpose of this meeting is to introduce the design concepts to the community, update you on the project schedule and provide information on how you can provide comments.

Slide 4 Title VI of the Civil Rights Act of 1964

This meeting is being held in accordance with city, state and federal regulations, including Title VI of the Civil Rights Act. Public participation is encouraged and solicited without regard to race, color, religion, sex, age, national origin, disability or family status. Slide 6 What is this Roadway & Safety Improvement Project?

This project consists of improving traffic channelization, eliminating dangerous turning movements, providing increased pedestrian access, upgrading transit stops, and offering additional storage to existing left turn lanes along Spring Hill Drive.

Slide 7 What is this Safety Improvements Project?

In accordance with the Florida Department of Transportation's Vision Zero policy, the Hernando/Citrus MPO aims to reduce traffic fatalities and serious injuries throughout Hernando County.

Slide 8 What does this mean for you?

This project will enhance safety. It includes upgrades for vehicles, bicyclists, and pedestrians, connectivity of sidewalks, new pedestrian intersection crossing, ADA-compliant features, access for transit stops and enhanced pedestrian visibility.

Slide 9 Project Location

The project limits surround Kass Circle, just over a half mile long, extending from Pinehurst Drive to Deltona Boulevard.

Slide 11 Spring Hill Drive Improvements

Below provides an overview of the Spring Hill Drive Improvements, including new median modifications, bus bay pullout area, and pedestrian crossing.

Slide 12 Existing Typical Section

Spring Hill Drive is a four-lane divided roadway with 10-foot travel lanes, paved shoulders, open ditches, and existing sidewalk on both sides. Currently, there are on-street bus stops along the corridor.

Slide 13 Proposed Improvements

This project will maintain the existing traffic and bicycle lanes. Existing left turn lanes will be extended at Pinehurst Drive, Acorn Circle, and Port Court. The sidewalk gap will be connected on the north side of the road, east of Pinehurst Drive. A new bus bay with shelter will be provided in front of the Spring Hill Plaza. Medians will be modified at the western end of Kass Circle, at Acorn Circle, and at Port Court.

Slide 14 Median Modification Locations

To enhance safety, median modifications at Kass Circle will include:

- *Replacing the existing directional median opening with a closed median opening*

Slide 15 Median Modification Locations

To enhance safety, median modifications at Acorn Circle will include:

- *Installing a directional median opening at the existing full median opening*

Slide 16 Median Modification Locations

To enhance safety, median modifications at Port Court will include:

- *Replacing the existing directional median opening with a closed median opening*

Slide 17 Bus Bay & Shelter

A bus bay is a designated spot on the side of a road where buses may pull out of the flow of traffic to pick up and drop off passengers. The purpose of the bus shelter is to safeguard the passengers from wind and rain to enhance the overall experience of the passengers waiting for the bus. The proposed bus bay is located between Kass Circle and Acorn Circle on the north side of Spring Hill Drive.

Slide 18 Enhanced Pedestrian Accessibility Rectangular Rapid Flashing Beacons (RRFBs)

Rectangular rapid flashing beacons enhance pedestrian and bicycle safety for posted speed limits of 35 mph and less. RRFBs are a warning device for drivers and include flashing lights. The

flashing yellow lights, when activated, signal to drivers and bicyclists using the roadway to yield to those in the crosswalk before proceeding. However, pedestrians need to remain aware and watch for approaching traffic even if the RRFB has been activated.

Slide 19 Enhanced Pedestrian Accessibility Pedestrian Hybrid Beacons (PHBs)

Pedestrian hybrid beacons enhance pedestrian and bicycle safety also but for speeds greater than 40 mph. PHBs include a phased sequence of signals to serve as a warning device for drivers. The traffic signal, when activated, alerts drivers and bicyclists using the roadway to stop for those waiting to cross. Similar to RRFBs, pedestrians need to remain aware and watch for approaching traffic even if the PHB has been activated.

Slide 20 Improve Safety

Studies show that lowering the speed limit from 40 mph to 35 mph can result in reduced fatalities and serious injuries.

Engineering analysis and design is currently underway. The design phase ends Summer 2022. Construction is estimated to begin sometime in 2023.
