Scope Approval to Benesch and Associates - Traffic Counts

BRIEF OVERVIEW

Traffic data is routinely obtained for input into the Congestion Management Process (CMP) which provides an annual 'snapshot' of the congestion levels on the classified road network. This information is an invaluable tool that delivers feedback on how and where to more effectually allocate resources.

The attached Consultant Work Scope of Services in the amount of \$19,948.02 will enable the MPO's General Planning Consultant (GPC), Benesch and Associates to provide count data at forty-four (44) count locations in Hernando County on County and local jurisdiction roads, State and Turnpike roadways are not included. Six (6) select locations will be counted in Citrus County on US 41 and SR 200 along past PD&E study corridors.

FINANCIAL IMPACT

Funding is programmed in Task 4, Data Collection, of the UPWP (Unified Planning Work Program) in PL Funding (Fund 1031, Dept. 34050, Account 5303107 - Hernando County budget) to perform traffic counts in Hernando and Citrus Counties.

2023 HERNANDO/CITRUS TRAFFIC COUNT PROGRAM HERNANDO/CITRUS METROPOLITAN PLANNING ORGANIZATION

SCOPE OF SERVICES

September 23, 2022

DESCRIPTION OF SERVICES

The purpose of this task is to continue the Hernando County Count Program by collecting new count data that can be used in assessing roadway conditions and levels-of-service for transportation and land-use planning applications. This task work order includes the count station locations chosen for 2023. In addition, special counts are being collected in Citrus County along two previous PD&E study corridors (US 41 and SR 200),

The Hernando County Count Program includes 173 count stations located throughout the County. Many of these stations are located on state roadways (66) and count data is collected by the Florida Department of Transportation and made available to the Hernando/Citrus Metropolitan Planning Organization (MPO).

For non-state facilities, the MPO uses its resources to collect traffic counts on a recurring basis. The frequency of a count being taken at a given location is determined by several factors, including total volume, roadway classification, volume/capacity ratio, and available resources as it is not financially feasible to count every station every year. The MPO staff analyzes these factors and determines which locations will be counted in any given year.

ACTIVITY SUMMARY

The following work tasks are associated with the 2023 traffic count data collection program:

- 2023 Field Data Collection
 - 72-Hour Volume Counts at 44 locations in Hernando County (County and local jurisdiction roads).
 - o 72-Hour Volume Counts at 6 locations in Citrus County (select locations on US 41 and SR 200).
- Data Download
 - o Field data will be downloaded and reported in standard format
 - o Volumes will be provided at 15-minute intervals to quantify demand at peak and off-peak times
- Quality Control
 - Downloaded data will be checked for consistency with count data from previous years and analyzed to ensure that no count errors or failure occurred during the duration of the count
 - o At locations where data errors are suspected or equipment failure evident, recounts will be taken
- Reporting and Deliverables

TASKS

Task 1 – Field Data Collection

The following requirements shall apply to the traffic count data collection program:

- Traffic count data shall be collected on Tuesdays, Wednesdays, and Thursdays, excluding holidays and those days immediately before and after legal holidays;
- The following information shall be compiled for each traffic count station:

- o Directional traffic volumes by 15-minute, 60-minute, and 24-hour intervals;
- o Directional, peak-hour traffic volumes;
- o Peak direction of traffic in the peak hour of each 24-hour period;
- GPS (Global Positioning System) coordinates shall be provided for each traffic count location and converted into Decimal Degrees;
- Count data shall be collected within the allotted time subject to weather and recount limitations;
- The CONSULTANT shall notify the MPO staff as soon as possible if field conditions are encountered that prohibit the collection of count data at any of the specified count station;
- The CONSULTANT shall follow the guidelines provided in the U.S. Department of Transportation; Federal Highway Administration Office of Highway Policy Information's "Traffic Monitoring Guide" dated September 2013 or later revisions;

Task 2 – Data Download and Processing

The following data download requirements shall be applied for each count:

- Standard and consistent care will be taken in downloading and processing count data per the instructions provided by the traffic count device manufacturer
- Counts will be processed using applicable software to ensure consistency
- Any errors in processing the data will be noted and the necessity for a re-count will be assessed on a case-by-case basis.

Task 3 – Quality Control

The following quality control procedures will be applied:

- Once processed, data results will be compared to previous years for consistency and order of magnitude
- Each count will be reviewed for consistency across days
- A review will be made of each count to identify any data gaps or indications of equipment malfunction or failure

Task 4 – Reporting and Deliverables

The following describe the reporting format and deliverables:

- A report document will be produced and delivered in draft and final version
 - o The report will include a county-level map which displays the locations of the 2023 counts
 - o The report will include a printout of count data at 15-minute intervals for each location.
- The MPO's count spreadsheet will be updated to include the 2023 counts

LOCATIONS TO BE COUNTED

Counts will be collected at fifty (50) locations in Hernando and Citrus Counties. These include forty-four (44) count locations in Hernando County on County and local jurisdiction roads only and do not include any State or Turnpike roadways. Six (6) select locations will be counted in Citrus County on US 41 and SR 200 along past PD&E study corridors.

PROJECT SCHEDULE

The counts will be collected over a 60-day period in the Spring of 2023. Field data collection will begin within two weeks of receipt of the official notice-to-proceed (NTP) being issued by the Hernando/Citrus MPO.

All deliverables will be provided within 30 days of the field data collection being completed (approximately 100 days from the official NTP).

FEE

A breakdown of the task fee is displayed in Exhibit A. The fee includes a unit cost for each count, plus hourly-based charges for processing, managing, and reporting the data. The total fee for collecting fifty (50) 72-hour counts is \$19,948.02.

BRIEF OVERVIEW

The purpose of the Hernando/Citrus MPO Vulnerability and Risk Assessment Study is to identify vulnerable transportation infrastructure assets and develop recommendations and mitigation strategies that promote system resilience. Transportation infrastructure construction and maintenance is programmed for normal operating conditions. This Study will identify hazards like catastrophic weather events such as: hurricanes, storm surges, flooding, sea level rise, and other conditions which may disrupt normal operating conditions or damage facilities for periods of time. A prioritized list of locations and mitigation strategies will be integrated into the 2050 Long Range Transportation Plan.

FINANCIAL IMPACT

Funding for this study is programmed in Task 5, Project Planning, in the adopted UPWP. Funding is available in the Hernando County budget in Fund 1031-34050-5303107 account.

October 25, 2022

Purpose and Objectives

Resilience from the transportation perspective is the ability of the transportation system to continue to provide residents with access and mobility in times of natural or man-made disruption. Foremost is the resilience of our coastal communities to the impacts of extreme weather-related events such as hurricanes, storm surge, and intense single-day rain events. Several federal grant and formula programs have been developed to assist communities in addressing these challenges through mitigation and adaptation strategies; at the same time, resilience has become a key consideration in the evaluation of transportation projects submitted for discretionary grant programs.

The purpose of this Hernando/Citrus MPO Vulnerability and Risk Assessment Study is to identify vulnerable transportation infrastructure assets and develop recommendations and mitigation strategies that promote system resilience. Transportation infrastructure construction and maintenance is programmed for normal operating conditions. This Study will identify hazards such as storm surge and flooding which can disrupt normal operating conditions or damage facilities over short and extended periods of time. Study results will include identifying the highest priorities for the MPO for planning and programming purposes and projects to protect the most vulnerable facilities through sound technical analysis and stakeholder coordination. Projects will be identified that can be incorporated into other MPO plans such as the Long Range Transportation Plan (LRTP), the List of Priority Projects (LOPP), and the Transportation Improvement Program (TIP).

Tasks and Deliverables

Task 1 - Vulnerability and Risk Assessment

A vulnerability and risk assessment will be performed to determine which facilities are at risk under certain events. Mapping the extent of certain events and estimating the impacts are important aspects of this task.

The following types of events will be measured for extent and duration of impact

- Coastal Flooding and Storm Surge associated with a named storm event. The Study will identify the level of storm intensity to be analyzed (i.e., Cat 1 or Cat 3)
- Inland Flooding resulting from a 1% Storm Event
- Consideration of wildfire hazards

Review of specific storm intensity and duration details will be coordinated with MPO Staff prior to conducting analysis necessary for conducting the vulnerability analysis.

Mapping the magnitude of risk events to identify vulnerable segments of the transportation network will be a large part of this task. Existing data sources and models will be used to identify facilities vulnerable to the weather-related events.

Data sources will be limited to existing and readily available sources. Example data includes the Florida Geographic Data Library (FGDL) and the Sea Level Scenario Sketch Planning Tool developed by the University of Florida GeoPlan Center for the Florida Department of Transportation and other readily available data which may be deemed necessary.

The results of the analysis will be the identification of the geographic extent of identified threats and a listing of effected transportation facilities and areas of vulnerability. For the transportation infrastructure these are areas impacted by storm surge, flooding. These results will be submitted in a draft technical memorandum to the MPO Staff. Following one round of comments, this technical memorandum will be finalized.

Deliverables:

Draft and Final Vulnerability and Risk Assessment Technical Memorandum

Task 2 – Menu of Mitigation Strategies

A full menu of mitigation strategies will be identified to strengthen the transportation infrastructure against potential threats. Mitigation strategies will include both preventive and post-event (recovery) strategies.

Preventive strategies addressing the resiliency of the transportation system may include incorporation of design and construction enhancements into project development and maintenance phases to mitigate the impact, severity, or disruption duration caused by the identified weather-related events. This could include such elements as drainage improvements, change in elevation or grade, Low Impact Development for the management of stormwater runoff, or upgraded materials and hardware for traffic signal systems. Additional adaptation strategies addressing coastal mitigation efforts will also be explored to reduce the severity of storm-related impacts system-wide.

Post-event construction and design standards within hazardous areas can be mitigation strategies used to upgrade or harden the transportation infrastructure through routing maintenance, reconstruction, and project enhancements. Such improvements will reduce the vulnerability of the transportation network in the long term and increase the resiliency of the transportation system.

A matrix of mitigation strategies and the potential impacts associated with weather related events will be prepared for review by the Technical Stakeholder Group. A revised matrix and technical memorandum will be developed following comments received by the Technical Stakeholder Group. This matrix will be used later in Task 4 when developing the action plan to relate the transportation system vulnerabilities with the appropriate mitigation strategies.

Deliverables:

- Draft Mitigation Matrix for review by the Technical Stakeholder Group
- Final Mitigation Strategy Technical Memorandum and Mitigation Matrix

<u>Task 3 – Prioritize Vulnerable Transportation Facilities</u>

Identified vulnerable transportation facilities will be prioritized based on a series of factors to determine the most critical segments of the transportation network. Potential prioritization schemes will be

discussed with the client and agreed upon prior to presenting to the Technical Stakeholder Group. Factors may include, but not be limited to:

- Roadway AADT
- Percent Heavy Vehicles
- Roadway Functional Classification
- Jurisdiction
- Evacuation Route Designation
- Roadway Profile
- Access to medical facilities and other essential services

Once a prioritization methodology is agreed upon the vulnerable segments of the transportation network will be evaluated and scored. With scores assigned, the vulnerable facilities will be ranked in order of criticality to determine the highest priority locations for implementing future mitigation related strategies as part of this risk assessment. The ranked roadway segments will be assigned to tiers for the purpose of advancing the top tier into the planning and implementation process.

Deliverables:

- Prioritization methodology
- List of prioritized critical and vulnerable transportation facilities

Task 4 – Recommendations

Using the Mitigation Matrix from Task 2 and the Top Tier of Vulnerable Transportation Facilities from Task 3, a list of recommendations will be produced to directly address the vulnerability of the Top Tier segments. These recommendations will draw from the menu of mitigation strategies identified in Task 2 such that the listing of potential strategies can be narrowed down to reflect the causal factor(s) resulting in the vulnerability designation.

Mitigation strategies will be categorized with a short-term or long-term implementation timeframe. Potential phasing and associated planning-level costs will be calculated as an aid to the MPO in selecting priorities for advancing into implementation through the LRTP, LOPP, and TIP. The result of these activities will be a Resiliency Action Plan. This Plan will define the specific strategies and locations to be considered.

Deliverables:

- Draft Top Tier Projects with Proposed Improvements and Costs
- Final Top Tier Projects with Proposed Improvements and Costs based on MPO Staff Comments

Task 5 – Stakeholder Meetings and Presentations

This Study is of a technical nature and meant to identify and solve specific issues related to resiliency. Therefore, the most effective form of outreach is through engaging a Technical Stakeholder Group. The stakeholder group will be comprised of a group of technical staff from transportation implementation agencies. It is recommended that the Technical Stakeholder Group for this Study include members of the MPO's Technical Advisory Committee and County-Level representation from the Hernando County and Citrus County Local Mitigation Strategy Working Groups, and the Florida Department of Transportation. Identification of Stakeholders and securing a location for Stakeholder Meetings will be the responsibility of the MPO Staff.

The Stakeholder Group will meet three times during the Study. The first meeting will be to assist in identifying vulnerable areas (See Task 1) based upon the collective knowledge of the Technical Stakeholder Group. Information such as locations of recurring flooding or extensive maintenance due to environmental factors will be used as supplemental information to the vulnerability and risk assessment.

The second meeting with be to discuss the mitigation strategies matrix (see Task 2) and to review the proposed prioritization methodology (see Task 3). It is important to have members of the Technical Stakeholder Group who represent local implementing agencies understand and come to agreement on the potential mitigation strategies that will be used later in developing the Resilience Action Plan.

The third meeting of the Technical Stakeholder Group will be to present the Top Tier of Most Vulnerable roadway facilities and the proposed mitigation strategies. Comments received during this meeting will be included in preparation of the Top Tier Projects with Proposed Improvements and Costs.

During this study, progress briefings will be made to the MPO Board and Advisory Committees. Facilitation of these presentation will be a joint effort shared by the MPO Staff and Consultant.

Responsibilities of the MPO Staff include a kick-off presentation to the MPO Board at the beginning of the Study to present the schedule and anticipated outcomes of the study. The MPO Staff will also make all presentations deemed necessary to the Advisory Committees.

Included in the Consultants scope of work is support to the MPO Staff in preparing presentation materials for all briefings and two (2) presentations to the MPO Board. The first presentation is anticipated to occur after the second Stakeholder Group Meeting to present the mitigation strategies matrix and prioritization. The second MPO Board presentation will follow the third Stakeholder Group Meeting and include presentation of the final draft Resilience Action Plan.

- Presentation Materials for use by MPO Staff during MPO Board and Committee meetings.
- Presentation of Mitigation Matrix and Prioritization to MPO Board
