INVOCATION

PLEDGE OF ALLEGIANCE

APPROVAL / MODIFICATION OF AGENDA (Limited to Staff and Committee Only)

New Business Item 5, Hunters Lake Canal, was moved up on the agenda following the Approval of Minutes – June 15, 2022. There were no other changes made to the agenda.

APPROVAL OF MINUTES – June 15, 2022

MOTION: Mr. Mike Fulford motioned to approve the minutes of the June 15, 2022 Waterways Advisory Committee meeting. Vice Chairman Sarah Hill seconded. The motion carried and was approved unanimously.

NEW BUSINESS

5. Hunters Lake Canal

Mr. Keith Kolasa advised the bid specifications for the Hunters Lake Canal project were completed and in the Purchasing Department for review. Ms. Dawn Roth provided photos for the record, indicating she resides next to the boat ramp and would like the canal dredged. She suggested the ramp be opened from dusk until dawn rather than 24-hours daily and expressed the Sheriff's Office was not helpful in enforcing the law on the canal as shooting occurs near her home and not within the designated parameters.

At the request of Mr. Mike Fulford, Mr. Keith Kolasa noted the Florida Fish and Wildlife Conservation Commission (FWC) 2019 Ordinance established for Hunters Lake related to hunting, indicating there are 10 canals with signage posted prohibiting hunting to keep hunters away from residences. Mr. Kolasa believed ducks could be hunted in the main lake early in the morning and early evening, not during the night.

Deputy Lapalme stated he would run the issue up the chain of command to see if a plan could be put in place to work with FWC and address the issues. He advised FWC is the enforcing agency and the Sheriff's Office is the backup, noting the hunters need to get caught in the act. Discussion ensued. Mr. Scott Herring advised Hunters Lake Boat Ramp was scheduled for discussion on the Board of County Commissioners' meeting agenda on August 23, 2022.

Mr. Erik Walasek queried what was next regarding tussocks. Mr. Keith Kolasa responded Mosquito Control had gone out for the past two years spraying, with the most recent one week ago, and there was funding allocated in the fiscal year 2023 budget for tussock maintenance.

Discussion ensued bringing back a homeowners' association for Hunters Lake. At the request of Mr. Mike Fulford, Mr. Scott Herring provided a brief overview of the Municipal Service Benefit Unit (MSBU) process available for property owners on Hunters Lake. Mr. Fulford noted that Hunters Lake is owned by the FWC and that our future state representatives should be lobbied for funding.

MARINE PATROL REPORT - Steve Snell

Deputy Lapalme stated it was his first time at the Waterways Advisory Committee meeting. He noted Hernando County had a lot of water and he and his partner were trying to switch up hours to work more evening hours for boaters coming back into the docks. During the weekend, their time was pressed spent patrolling the flats, canals, Weeki Wachee River, etc. Deputy Lapalme requested citizens bring any concerns directly to him or Deputy Snell.

Deputy Lapalme indicated there had been issues with getting repair parts for vessels due to manufacturing delays and everything was fixed for now. He advised there was a new shallow water vessel coming in which would eventually replace the skis, and an additional position (third) for a marine patrol officer had been funded in the next budget proposal.

NEW BUSINESS

- Update on State Road Canal Dredging (County) and Weeki Wachee River Dredging (SWFWMD) https://www.swfwmd.state.fl.us/projects/springs/weeki-wachee-channel-restoration-project Mr. Keith Kolasa noted the State Road Canal Dredging project was 95% dredged and cleanup of overflow needed to be completed. The Weeki Wachee River Dredging project was on hold due to permitting.
- 2. Florida Fish and Wildlife Conservation Commission (FWC) Public Workshop on Weeki Wachee River Springs Protection Zone August 2, 2022
 Mr. Mike Fulford attended the Florida Fish and Wildlife Conservation Commission (FWC) Public Workshop on the Weeki Wachee River Springs Protection Zone held on August 2, 2022. He

provided an overview on how the application for the Springs Protection Zone began and the FWC process. It was unknown at this time when the FWC hearing would be held. Mr. Fulford indicated Hernando County had made a substantive case there was damage to the Weeki Wachee River to prohibit mooring, beaching, and anchoring from the headwaters of the springs to Rogers Park. The residential portion of the river run was not grandfathered but was not considered to be in that river zone. Residents living along the proposed Springs Protection Zone would not be affected.

3. Pine Island Dredge - Design and Permitting

Mr. Scott Herring stated the first budget hearing was scheduled to be held on September 13, 2022, and design and permitting for the Pine Island Dredge project was to be included in the budget. He explained Pine Island Dredge was funded in Pot 3 of the Restore Act, but if you have design and construction and any modifications are needed, it triggers the amendment process anywhere from three months to one year. Therefore, it is quicker for the County to pay for design and permitting while working on the application for construction in Pot 3 funds.

Upon query, Mr. Keith Kolasa responded the Pine Island canal is to be restored to where it's navigable.

4. Boat Ramp Dock Replacements

Mr. Eric Davis announced approval to replace the boat ramp docks was received, a contractor was selected, and he was waiting for the plans from the contractor to move forward with permitting. He noted that once permitting was approved, Aquatics/Waterways Department would be installing the docks at Hernando Beach county ramps (both courtesy docks), and Bayport ramp (western most courtesy dock).

OLD BUSINESS – Adopted Ordinance on Mooring of Commercial Vessels at Boat Ramps – BOCC Adopted June 28, 2022

The Ordinance on Mooring of Commercial Vessels at Boat Ramps was adopted by the Board of County Commissioners (BOCC) on June 28, 2022. A copy of the adopted Ordinance was included in the agenda packet for the Committee's information. Chairman Kathryn Birren noted she had attended the BOCC meeting. She advised the sign at the Hernando Beach boat ramp specifying the old Ordinance and penalties for docking had been removed. Mr. Kolasa provided a review of the changes made to the adopted Ordinance.

INFORMATIONAL ITEMS – FWC Vessel Turn-In Program, Derelict Vessel Prevention Efforts https://myfwc.com/news/all-news/vtip-722/

Mr. Keith Kolasa announced the program was established to have boats turned in before they become derelict vessels in canals and out in waters. He expressed this was a great program as Hernando County has derelict vessels that have been in the water for years. Mr. Mike Fulford inquired if the County's Public Information Office could issue a media release to the coastal residents advising them of the program. Mr. Scott Herring advised the FWC approved the program at its last meeting, but he was not sure whether the rule had been finalized and promulgated, so we would need to wait prior to issuing a media release. He indicated there was \$36.4 million in funding over four years and once the program was finalized by the FWC, the Committee would be advised, and a media release would be issued advising of the program and contact information. Mr. Fulford requested the item be brought back at the next meeting and have Mr. Herring provide an update on the program's enactment. Chairman Birren concurred.

It was noted the FWC was aware of the current derelict vessels on the coastline in Hernando and already had a list. Upon query by Chairman Birren, it was further noted Lieutenant Grover at the FWC would most likely have the current list.

CITIZENS' COMMENTS

Ms. Valerie Shelter inquired on the status of the Hernando Beach Channel Seagrass Mitigation permit status. Mr. Keith Kolasa responded the Department of Environmental Protection (DEP) monitoring results showed there were some growth areas and some offset areas that didn't work mitigation; however, DEP had released the County from monitoring. The Army Corps of Engineers report was being worked on for the offset areas and once released, then the permit application could be filed.

Discussion ensued.

Mr. Chuck Morton stated the County received credit from the seagrass that grew back in the channel and that funding from hurricanes was appropriated by event.

There were no other citizens' comments.

APPROVAL / MODIFICATION OF AGENDA (Limited to Staff and Committee Only)

There were no changes made to the agenda.

APPROVAL OF MINUTES – February 16, 2022

MOTION: Mr. Mike Fulford motioned to approve the minutes of the February 16, 2022 Waterways Advisory Committee meeting. Mr. Chris Licata seconded. The motion carried and was approved unanimously.

MARINE PATROL REPORT - Steve Snell

Mr. Keith Kolasa indicated Mr. Steve Snell had informed him he was not able to attend the meeting.

NEW BUSINESS

1. Update on State Road Canal Dredging (County) and Weeki Wachee River Dredging (SWFWMD) https://www.swfwmd.state.fl.us/projects/springs/weeki-wachee-channel-restoration-project Mr. Keith Kolasa advised Rogers Park would be closed for one month as dredging was to start next week on the State Road Canal. The Weeki Wachee River dredging would start afterwards, with both projects anticipated to be completed in November 2022. Mr. Eric Davis, new Waterways Project Manager, was in attendance at the meeting and would be overseeing both dredging projects.

Vice Chairman Sarah Hill queried why dredging was being started up the river instead of at the bottom. Mr. Kolasa responded they originally had plans to start up the river; based on changes in plans, they were starting on the west. Upon query by Mr. Mike Fulford, Mr. Kolasa responded Rogers Park was a dewatering site. Upon further query by Mr. Fulford, Mr. Kolasa responded the Southwest Florida Water Management District (SWFWMD) was fully funding the Weeki Wachee River Dredging project.

Discussion ensued. It was noted that sediment material was clean.

Chairman Kathryn Birren stated she had attended the Board of County Commissioners' (BOCC) meeting on June 14 and had voiced her concerns regarding persons floating in inner tubes and bumping and climbing onto the dredging equipment. She advised the BOCC's consensus was to speak to the dredging contractor and require them to hire security to keep people back and off the equipment. Upon query by Chairman Birren, Mr. Kolasa responded an inquiry could be made to find out if SWFWMD was requiring the contractor to have security. He referenced the SWFWMD link indicated on the agenda for project information while dredging was ongoing.

2. Lake Lindsey Tussock Control

Mr. Keith Kolasa noted many complaints had been received regarding Lake Lindsey being blocked with tussock. He displayed photos of Lake Lindsey boat ramp included in the agenda packet, which had been recently tussock maintained by Aquatics/Waterways. Mr. Kolasa indicated funding has been requested in next year's budget for tussock maintenance.

Chairman Kathryn Birren advised she spoke with local residents at Mountain Lake, and they indicated seeing dead fish and unable to catch any fish. They had suggested if restocking could be done at the lake. Mr. Kolasa responded they should reach out to the Florida Fish and Wildlife Conservation Commission (FWC) and request restocking.

3. Overview of East Side Boat Ramps – Lakes and Withlacoochee River

Mr. Keith Kolasa continued with the display of photos included in the agenda packet, including Lake Townsen, Nobleton, Mountain Lake, and Bystre Lake ramps. Mr. Kolasa noted the ramps were paid for by Waterways through a boating improvement grant and the parking lots were paid for by Parks & Recreation, along with the docks and fishing piers.

Chairman Kathryn Birren advised there was no signage leading up to Bystre Lake. Mr. Kolasa responded he would follow up with the Florida Department of Transportation (FDOT) and the Department of Public Works for signage to be placed.

Chairman Birren informed she took a trip out to Lake Townsen and displayed a video of the conditions of the ramp and fishing pier. There was a family at the site which Chairman Birren interviewed and they shared their concerns. Concerns noted on the dock were saggy, rotted wood, planks of wood missing, and that it was very dark out by the water. Mr. Kolasa advised funding for design and permitting was scheduled in the FY 25 Capital Improvement Program (CIP) with construction anticipated in FY 26 CIP.

Vice Chairman Sarah Hill indicated Lake Townsen boat ramp was not listed on the Hernando County Waterways website. Mr. Kolasa responded he would follow up and have it added.

4. Personal Flotation Device Zone Signage at Boat Ramps

Mr. Keith Kolasa announced stencil was purchased and all life jacket zones at boat ramps would be updated.

5. Signage at Boat Ramps

Mr. Keith Kolasa noted signage at the various boat ramps displayed restrictions and regulations on the use of vessels, and as Chairman Kathryn Birren had previously indicated, Hernando Beach was the only one displaying signage specifying the Ordinance and penalties for docking. Chairman Birren expressed concern over the Ordinance's validity and whether it should be countywide. Mr. Kolasa advised further research on the Ordinance would be needed and that it was separate from the mooring of vessels Ordinance to be presented to the BOCC.

Mrs. Diane Greenwell requested signage indicating the noise level be displayed as she is still concerned with the airboat at night. Mr. Kolasa noted the sign was displayed at Hernando Beach.

Mr. Mike Fulford suggested to invite Marine Captain Jeff Kraft to attend the next Waterways Advisory Committee meeting to discuss noise concerns and the Ordinance in place regarding marine patrolling. Chairman Birren agreed.

OLD BUSINESS

1. Draft Letter in Support of Additional Law Enforcement for Springs Protection and Waterways

Chairman Kathryn Birren inquired on the status of the draft letter in support of additional law enforcement for springs protection and waterways. Mr. Scott Herring informed of the current process for the establishment of the Springs Protection Zones, and a response to Hernando County's presentation was anticipated at the July 13-14 FWC meeting in Jacksonville. Mr. Herring further informed the meeting agenda was not available as of the Committee meeting date. He advised the Hernando County Sheriff's Office had allocated one additional marine patrol officer in next year's budget and if that was the intent of the draft support letter, then it was already accomplished. The Committee concurred to hold off on forwarding the letter through to the BOCC at this time.

2. Florida Fish and Wildlife Conservation Commission Final Meeting to Review Establishment of Springs Protection Zones – July 13-14, 2022, Jacksonville, Florida

Discussion continued regarding Springs Protection Zones, the FWC meeting scheduled on July 13-14 in Jacksonville, and access by residents to the Weeki Wachee River. Mr. Scott Herring provided a brief overview of the intent of the Springs Protection Zones and noted it was not guaranteed to be on the July 13-14 agenda. He advised a public workshop was scheduled in the future and he would get the FWC information to the Committee.

3. Hunters Lake Aquatic Plant Maintenance

Mr. Keith Kolasa noted spraying and aquatic plant maintenance was ongoing at Hunters Lake.

4. Hunters Lake Access Canal Dredging

Mr. Keith Kolasa advised the bid packet for the Hunters Lake canal dredging project was being compiled and would be out to bid in the next few months.

5. Coastal Conservation Association Donation for 2022 Artificial Reef Project

Mr. Keith Kolasa stated the donation from the Coastal Conservation Association (CCA) for the artificial reef project was approved by the BOCC on June 14, 2022.

6. Coastal Conservation Association Donation for Living Shoreline Project at Jenkins Creek Mr. Keith Kolasa indicated he had recommended the donation from CCA for the living shoreline project be handled through UF/IFAS, which was approved by the BOCC on June 14, 2022. Chairman Kathryn Birren shared she had attended the BOCC meeting and thanked CCA for their donations. She noted CCA had encouraged Waterways to submit projects for consideration.

INFORMATIONAL ITEM – Revisions to Proposed Ordinance on Mooring of Commercial Vessels at Boat Ramps – BOCC Public Hearing June 28, 2022

Mr. Keith Kolasa stated the requested revisions to the proposed Ordinance on Mooring of Commercial Vessels at Boat Ramps had been made and was scheduled for public hearing before the BOCC on June 28, 2022. A copy of the proposed Ordinance was included in the agenda packet for the Committee's information. Chairman Kathryn Birren advised she would be present at the BOCC meeting to express her concerns regarding temporarily tying a vessel to a dock to get vehicle and being cited for mooring.

CITIZENS' COMMENTS

Mr. Steve Barton inquired on the status of the Engineering reef contracts. Mr. Keith Kolasa responded GIS data collection was complete and 15 sites had been identified from 30. He informed request for quotes were out and should be back in next week.

There were no other citizens' comments.

OTHER – Waterways Advisory Committee Agenda Requests for Future Meetings

Mr. Keith Kolasa reiterated the Springs Protection Zone information would be added to the next meeting agenda, and an invitation would be extended to Captain Jeff Kraft to attend the next meeting. Chairman Kathryn Birren reminded to add airboats to the next meeting agenda.

Mr. Mike Fulford queried on the status of the Calienta Street/Petit Lane project. Mr. Scott Herring responded 60% Plans were reviewed and submitted back to the Contractor. It was anticipated nine months for receipt of Restore Act funds and therefore, the project would not be out for bid until sometime next Spring. Mr. Fulford inquired whether the entire parcel of land adjacent to Zig Zags would be used and the balance excess. Mr. Herring responded he would have to review the Plans and get back to Mr. Fulford with a response.

Mrs. Diane Greenwell inquired on the previously issued funds by the Legislature for Calienta Street. Mr. Herring replied those funds by the Legislature were for the design of the project and construction was funded through the Restore Act.

Mr. Charles Greenwell queried how much money was used for the design of Calienta Street. Mr. Herring responded he did not have those numbers, but they were most likely published in the CIP available on the County Budget's webpage.

Upon query by Chairman Birren, Mr. Herring responded construction on the project could potentially not commence until next Fall due to materials and contractor shortages.

Waterways Advisory Committee Meeting Minutes – June 15, 2022

Mr. Chris Licata expressed concern with improvements to the public access ramp on Bystre Lake as it impeded onto private lake and suggested taking possession of the lake. Mr. Kolasa responded these issues have been brought up in the past and he would need to review.

There was no other business.

ADJOURNMENT

The Committee concurred to have the next meeting back in Hernando Beach.

The meeting was adjourned at 8:40 p.m.



The 2021 Florida Statutes

Title XXIV Chapter 327 View Entire Chapter VESSELS VESSEL SAFETY

327.45 Protection zones for springs.—

- (1) As used in this section, the term "navigable waters of the United States" means the waters of the United States, including the territorial seas, as referenced in the Clean Water Act, 33 U.S.C. ss. 1251 et seq., and the federal rules and regulations promulgated thereunder.
- (2) The commission may establish by rule protection zones that restrict the speed and operation of vessels, or that prohibit the anchoring, mooring, beaching, or grounding of vessels, to protect and prevent harm to first, second, and third magnitude springs and springs groups, including their associated spring runs, as determined by the commission using the most recent Florida Geological Survey springs bulletin. This harm includes negative impacts to water quality, water quantity, hydrology, wetlands, and aquatic and wetland-dependent species.
- (3) When developing a protection zone, the commission shall do so in consultation and coordination with the water management district, the Department of Environmental Protection, and the governing bodies of the county and municipality, if applicable, in which the zone is located. If the zone includes navigable waters of the United States, the commission shall additionally coordinate with the United States Coast Guard and the United States Army Corps of Engineers.
- (4) Any individual who operates a vessel in violation of a spring protection zone rule adopted pursuant to this section shall be charged on a uniform boating citation as provided in s. <u>327.74</u> and is subject to the penalties provided in s. <u>327.73(1)(y)</u>.
 - (5) Restrictions in a protection zone do not apply:
- (a) To law enforcement, firefighting, or rescue personnel operating a vessel in the course of performing their official duties; or
- (b) In emergency situations. However, the emergency operation of a vessel must be a reasonable response given the circumstances.
- (6) The commission is responsible for the posting and maintenance of regulatory markers identifying protection zones.
 - (7) The commission may adopt rules to implement this section. History.—s. 1, ch. 2016-233; s. 15, ch. 2021-184.

MEMORANDUM

Subject: Proposed Final Rule – Springs Protection Zones

Purpose: Obtain approval to create guidelines and criteria for the establishment of Springs Protection Zones.

Why: Pursuant to Section 327.45, F.S., it is necessary to create clear criteria for the establishment of Springs Protection Zones.

Top Points:

- 1) The proposed final rule outlines criteria the Commission will use to create Springs Protection Zones.
- 2) Any person may provide evidence to the Commission to determine if a springs protection zone should be established.
- 3) The Commission will consult with the Department of Environmental Protection (DEP), the relevant Water Management District, and other entities as appropriate when establishing these zones.

Affected Parties: The boating public, Floridians, and visitors to the state.

Summary: Section 327.45, F.S. grants authority to the Commission to establish Springs Protection Zones that restrict the speed or operation of vessels or that prohibit anchoring, mooring, beaching, or grounding of vessels to protect or prevent specified harm to first, second, and third magnitude springs and spring groups, and their associated spring runs. The proposed rule will create clear guidelines and criteria for the establishment of Springs Protection Zones. Evidence will be required, showing the specific harm that may occur as a result of vessel speed or operation, or the anchoring, mooring, beaching, or grounding of vessels. Any person may provide evidence to the Commission for use in the evaluation. The Commission will consult with DEP, the relevant Water Management District, local governing bodies, the U.S. Coast Guard and the Army Corps of Engineers where appropriate, when evaluating the evidence.

Each Springs Protection Zone will be adopted by separate rule following Commission review of available evidence showing that the zone will protect or prevent specified harms from being done by vessels to the spring, spring group, or spring run. Following adoption of such a zone via rule by the Commission, the FWC will post uniform waterway markers prior to enforcement. The current rule does not create any Springs Protection Zones.

Staff held public workshops on this proposed rule and solicited online comments from interested stakeholders. Staff fielded no opposition to the proposed rule language.

- May restrict speed and operation
- May prohibit anchoring, mooring, beaching or grounding





Section 327.45, F.S. provides rulemaking authority for the Commission to create Springs Protection Zones that prohibit anchoring, mooring, beaching, and grounding and restrict the speed and operation of vessels within first, second and third magnitude springs and spring groups and their associated spring runs for the purpose of protecting and preventing specific types of harm to the springs.

Requires evidence of harm and that harm is caused by vessels. Any person may provide evidence to the Commission for use in evaluation May include carrying capacity studies, vessel traffic studies, water quality studies or any facts or data that are of a type reasonably relied upon by scientists, environmental professionals, or engineers.

Evidence will be required for the establishment of a Springs Protection Zone, showing that regulation will protect or prevent specified harms caused by the speed, operation, anchoring, mooring, beaching, or grounding of vessels.

Any person may provide evidence to the Commission for use in evaluation.

Evidence may include carrying capacity studies, vessel traffic studies, water quality studies or any facts or data that are of a type reasonably relied upon by scientists, environmental professionals, boating professionals or engineers.

Review and Approval FWC will consult with the relevant water management district, as well as other entities, as necessary If evidence demonstrates a springs protection zone will protect or prevent specified harms to a spring or opring group and associated spring runs, staff will recommend the rule be adopted by the Commission Upon Commission approval, FWC will mark springs protection zones with uniform waterway markers

FWC will consult with the relevant water management district, as well as other entities, as necessary, to evaluate whether regulation will protect the spring or prevent harm of a specific type identified in the statute. Following adoption of a Springs Protection Zone by the Commission, the FWC will post uniform waterway markers prior to enforcement.

68D-24.0035 Protection Zones for Springs.

- (1) The Commission will establish a springs protection zone restricting speed and operation or prohibiting anchoring, mooring, beaching, or grounding of vessels within a first, second, or third magnitude spring or spring group, and associated spring runs when evidence demonstrates that a zone will protect or prevent the spring, spring group, or spring run from harm of the type identified in Section 327.45, F.S.
- (2) Evidence of the need for spring protection or to prevent harm may include vessel carrying capacity studies, vessel traffic studies, vegetation or water quality studies, or any facts or data that are of a type reasonably relied upon by scientists, environmental professionals, boating professionals or engineers.
- (3) Any person may provide evidence to the Commission for use in the evaluation of a spring, spring group, or spring run under subsection (1).
- (4) Springs protection zones shall be no larger than necessary to protect or prevent specified harms to springs, spring runs, and spring groups.
- (5) Following the Commission's adoption of a springs protection zone by rule, the zone will be enforceable once the Commission posts uniform waterway markers notifying the public of the regulations applicable in the zone.

BRIEF OVERVIEW

The attached letter to Florida Fish and Wildlife Conservation Commission (FWC) is requesting the FWC establish by rule a protection zone that prohibit the anchoring, mooring, beaching, or grounding of vessels, to protect and prevent harm the Weeki Wachee River which is a spring run from a first magnitude spring.

The County conducted a Natural System Carrying Capacity Study that resulted in the data showing the degradation to the natural systems on this river from the out of vessel activities in the river, and the beaching and grounding of vessels.

The Hernando County Board of County Commissioners is requesting this protection zone to reduce the degradation of the ecosystem surrounding the Weeki Wachee River.

Dear Major Beaton:

Historically, the Weeki Wachee Springs and River's "exceptionally clear water and natural vegetation and wildlife" have made the river a destination for local residents within Hernando County and "visitors from around the world". Historically, recreational activities such as, but not limited to, swimming, jumping off of trees, and socializing in the river have been enjoyed by local residents and tourists alike. However, the growing popularity of the river and heightened visitor traffic has led to degradation of the Weeki Wachee River and its surrounding ecosystem, as noted in the "Weeki Wachee Natural System Carrying Capacity Study-Analysis and Reporting, Final Report" by Wood Environment and Infrastructure Solutions, Inc., Prepared for the Southwest Florida Water Management District (SWFWMD) and Hernando County, Florida. The Carrying Capacity Study¹ explicitly noted the links between vessel docking and ecological damage of the river, "denudation appears to be initiated by vessel docking dislodging organic soils and vegetation. This sets up a cascading series of events by facilitating more foot traffic at the impacted areas, expanding the denudation". Furthermore, the Carrying Capacity Study¹ highlights the vessel usage has had a detrimental impact on the water quality of the Weeki Wachee River, "the cumulative number of vessels/users and in-water activities such as docking, wading, and swimming contributed significantly to turbidity along the river, which suggests that recreation has negative effects on water quality"¹. Moreover, the Carrying Capacity Study¹, asserts that to protect the integrity of the river, management options can be taken, such as limiting "access to landing points for docking and exiting vessels to designated areas"1.

Furthermore, in order to protect the ecological environment including natural vegetation and wildlife within the Weeki Wachee River, we (Hernando County Board of County Commissioners) request the Florida Fish and Wildlife Conservation Commission (FWC), in accordance with Florida Statue 327.45, titled "Protection zones for springs", create an anchoring, mooring, beaching, and grounding prohibition zone between the defined

location coordinates of upstream boundary at the State Park Corridor located at Latitude 28 31 34.2 Longitude 082 35 55.4 towards the Rogers Park boat ramp canal at Latitude 28 31 54.3 Longitude 082 37 35.1, which are shown on the attached map below³. This zone would be in accordance with Chapter 327 Section 45, Florida Statutes (2021)², which directly states that "The commission may establish by rule protection zones that restrict the speed and operation of vessels, or that prohibit the anchoring, mooring, beaching, or grounding of vessels, to protect and prevent harm to first, second, and third magnitude springs and springs groups, including their associated spring runs, as determined by the commission using the most recent Florida Geological Survey springs bulletin. This harm includes negative impacts to water quality, water quantity, hydrology, wetlands, and aquatic and wetland-dependent species"².

Subsequently, we request that any individuals or groups that operate a vessel in violation of the spring protection zone, pursuant to Chapter 327, Section 45, Florida Statutes (2021)², shall be charged on a uniform boating citation as stated in Chapter 327 Section 74, Florida Statutes (2021)⁴, and be subject to the penalties listed in Chapter 327, Section 73, subsection (y) (1-4), Florida Statutes (2021)⁵. Moreover, we further request that the only individuals and/or groups that shall be exempt from the prohibited anchoring and mooring zone be Hernando County, Southwest Florida Water Management District (SWFWMD), Hernando County Sheriff's Office (HCSO), Florida Department of Environmental Protection (FDEP), and Florida Fish and Wildlife Conservation Commission (FWC) authorized vessels conducting official business on behalf of their associated agencies. Additionally, we understand that this protection zone shall not apply to property owners along the Weeki Wachee River for the purpose of docking their personal vessels on water adjacent to their property.



At its July meeting, the Florida Fish and Wildlife Conservation Commission (FWC) approved the final rule establishing a statewide Vessel Turn-In Program (VTIP) as part of the Derelict Vessel Prevention Program. The new rule will create a voluntary program to remove at-risk vessels before they become derelict, which helps Florida's environment and public safety.

The Division of Law Enforcement's Boating and Waterways Section is spearheading a multi-year effort to dramatically reduce the backlog of derelict vessels currently on Florida's waters. These vessels cause the destruction of valuable seagrass resources and endanger marine life. They also threaten human life, safety and property as they drift on or beneath the surface of the water or block navigable waterways, posing a navigational hazard to the boating public.

Recent legislation enables the FWC to create a Derelict Vessel Prevention Program, and the VTIP is one component of the FWC's approach to derelict vessel prevention.

"Commissioners receive numerous contacts from the public about derelict vessels and I know the establishment of this new program will really make a difference," said FWC Chairman Rodney Barreto. "Thanks to the efforts of Senator Ben Albritton, Representative Josie Tomkow, Representative Jay Trumbull and Senator Kelli Stargel, we've received the resources and the legislative support to make this program a reality."

Derelict vessels are more costly and complicated to remove than at-risk vessels. A VTIP will prevent vessels from becoming derelict by removing them from the state's waters when they are at risk of becoming derelict, which will result in cost savings for taxpayers and ultimately fewer DVs appearing on Florida waters. The VTIP is designed to allow owners of vessels at risk of becoming derelict the ability to voluntarily turn the at-risk vessel over to the state for removal and destruction.

"Derelict vessels are a priority for the FWC. Establishing the Vessel Turn-In Program provides a voluntary pathway for owners to remove at-risk vessels from the water before becoming derelict, thereby reducing future costs of removal. Removing at-risk vessels from Florida's waterways before they become derelict is not only a win for the environment but also for public safety, taxpayers and the vessel owners," said Col. Roger Young, director of the FWC Division of Law Enforcement.


