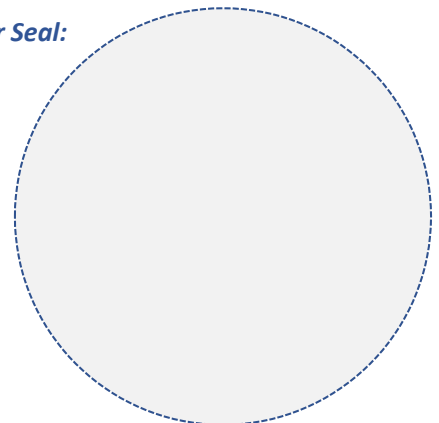
**CALCULATION CRITERIA**

2. TAP IN FEES: Calculated by meter size up to 2" (water)
3. DEPOSITS: Based on meter size
4. NO connection fees to be paid by the School Board
5. NO deposit fees to be paid by Hernando County Government Departments
