<u>PUBLIC SERVICE DEMONSTRATION OF BOARDING AND OFFBOARDING BY DISABLED INDIVIDUALS ON A PUBLIC TRANSIT VEHICLE EQUIPPED FOR PERSONS WITH A DISABILITY</u>

Vice Chair Douglas, who is a wheelchair user, explained that the importance of the public service demonstration was for the Board to understand what is involved in receiving services on a public transportation vehicle equipped for persons with disabilities. Vice Chair Douglas also shared that Board member, David Knazur, would be participating in the demonstration as a wheelchair user and Tracy Noyes, another Board member, would demonstrate a person who is visually impaired. The meeting temporarily adjourned to the parking lot for the public service demonstration at 10:42 a.m.

Vice Chair Douglas reiterated the benefits and importance for the Board to fully understand and comprehend how to assist persons with disabilities who utilize the public transportation services.
