


• After the **Governor** signs the work program, the first year is included in the state budget and the work program is considered **Adopted**.






Facilities in Hernando/Citrus Region



Suncoast Parkway (SR 589) 31 Miles






Revenues & Expenditures

Turnpike Prioritization Process









The project also includes extending the Suncoast Trail from CR 486 to CR 495. The goal of the Suncoast Parkway 2 is to serve the future traffic needs of Citrus County as well as the public traveling to and from the Tampa area through Citrus County. It will also assist with evacuation and recovery in the event of a hurricane or other emergency. The project is subject to a test of economic feasibility according to Florida Statutes. A third segment will extend the facility to US 19.

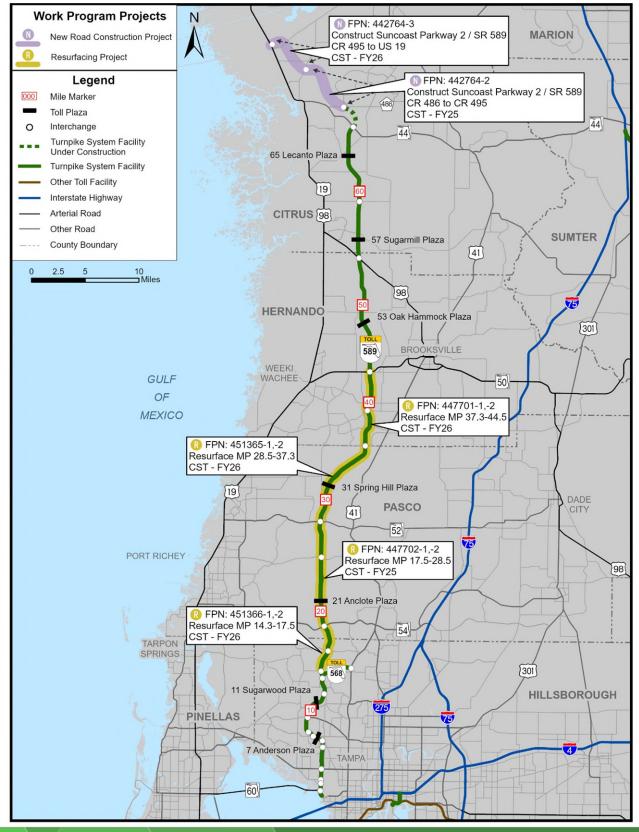
New Road Construction Project
