DO NOT RETURN WITH PERMIT APPLICATION DISCHARGE REQUIREMENTS

NOTE: ONLY SEPTAGE OR PORTABLE TOILET WASTE ORIGINATING IN HERNANDO COUNTY WILL BE ACCEPTED.

1. The discharge of all hauled wastes must be performed at the designated areas:
 - a. Hernando Airport Subregional Water Reclamation Facility septic receiving station.
 - b. Glen Lakes Water Reclamation Facility septic receiving station.Discharge of septic and portable toilet is prohibited at any other wastewater treatment plant location.
2. Discharge may be performed 24 hours a day.
3. Hauled wastes are subject to sampling by Hernando County Utilities Department. The hauler may be required to suspend the discharging of wastes until the analysis is complete. Hernando County Utilities Department reserves the right to refuse permission to dump any load.
4. **Access to this system is contingent on maintenance of a State of Florida License for Sewage Disposal Service.** If the State license is allowed to lapse or is revoked by the State, Hernando County Septic and portable toilet service will be terminated.
5. Permit holders must maintain their account with Hernando County Utilities Department in good standing. Any user not paying their Hernando County account within 20 days of the billed due date will not be allowed further use of the septic station until such time as the account is paid in full.
6. All wastes shall be declared on the discharge/manifest form and shall not contain a prohibited discharge. This form must be available during offloading at the receiving stations. Users must also keep records of these forms for a minimum of 2 years.
7. Disposing of any material other than residential septic tank waste and approved portable toilet wastes is **strictly prohibited**.
8. **Violation of any applicable provisions of Florida Statutes, rules or regulations adopted there under, or any applicable provisions of the Hernando County Code of Ordinances may result in suspension or revocation of permit privileges, licenses and/or civil or criminal penalties. Only materials from septic and port-o-lets originating in Hernando County can be processed at this facility**

SPECIFIC LIMITATIONS

1. No industrial or business wastes including wastes from any sand/oil separators, grease traps, hot tanks, dip or batch tanks, or any other tank, pit, pond, or container used to hold wastes or products used in a business or related purpose, or wastes from other than domestic residential use, shall be accepted for disposal at the Hernando County Utilities septic dump station.
2. Any waste that may cause pass through of pollutants or interfere with the wastewater treatment plant operations or that violates Federal, State or local restrictions shall not be discharged to the Hernando County Utilities septic dump station treatment system.

3. The permittee is prohibited from discharging wastes that are listed below:
 - Any septic or portable toilet waste originating from outside of Hernando County
 - Containing fats, wax, grease or oils of petroleum origin, whether emulsified or not;
 - Containing any liquids, solids, or gases that can create fire, explosion, or health hazard;
 - Containing any substances capable of causing obstructions or other interferences with proper operation of the sewer system;
 - Containing any pollutant which will cause a pass through of pollutants to occur or an interference with Hernando County wastewater treatment facility's operations or sludge use and/or disposal practices;
 - Containing any wastes, wastewater treatment plant sludge, screenings or other residues from business or industrial wastes, or the pretreatment of business or industrial wastes;
 - Containing detergents, surface active agents, or other substances which may cause excessive foaming in the wastewater system;
 - Containing ammonia, ammonia salts, or other chelating agents which will produce metallic complexes that interfere with the municipal wastewater system;
 - Containing material considered a hazardous waste under the ... or materials that are toxic, hazardous, radioactive, or infectious medical wastes.

MONITORING AND RECORDS

1. The County shall have the right to access to all parts of the vehicle dumping on premises for the purposes of inspection, sampling and records examination and copying, and the performance of any additional duties.
2. All septic wastes must be accompanied by a completed waste manifest slip. All information regarding the waste's origin and the signature of each waste generator will be included. The hauler shall also sign the form, indicating that he has accepted no wastes other than those listed. Failure to accurately record every load, falsification of data, or failure to transmit the form to the County prior to discharge may result in service suspension.
3. The permittee shall retain records of all monitoring information, waste manifest forms, copies of any reports required, and records of all data pertaining to hauled loads for a period of at least two years.

GENERAL CONDITIONS

1. **Severability** - The provisions of this application are severable, and if any provision of this permit, or the application of any provision of this permit to any circumstance, is held invalid, the application of such provision to other circumstances, and the remainder of this permit, shall not be affected.
2. **Duty to Comply** - The permittee must comply with all conditions of permit issued. Failure to comply with the requirements of permit may be grounds for administrative action, or enforcement proceedings including civil or criminal penalties.
3. **Duty to Mitigate** - The permittee shall take all reasonable steps to minimize or correct any adverse impact to the public treatment plant or the environment resulting from noncompliance with permit, including such accelerated or additional monitoring as necessary to determine the nature and impact of the event.
