Upon the acceptance for filing of a building permit application for the construction of the improvements described in the <b>Construction Contract</b> , a building permit must be issued pursuant to said application no later than <u>one hundred and eighty (180) days</u> of said filing; <b>or</b> the afore-described exemption shall be forever forfeited and the prevailing impact fee rates shall thereafter apply. Hernando County shall not be responsible for any failure to issue a building permit within this time frame.
